

# Table of changes to fee and levy rates

Please note that the **table of changes to fee and levy rates** is intended only as a general guide. Every application is different, so we recommend you use the **Fee Finder** tool on our website to see what you will be required to pay when you apply for a visa, and it's important to note the fee finder was updated on 1 October to reflect the new visa charges and increase to the International Visitor Conservation and Tourism Levy (IVL) that came into effect on that date.

Most international visitors applying for a visa or NZeTA (New Zealand Electronic Travel Authority) to enter New Zealand need to pay a non-refundable IVL. The current charge is NZD \$100 per eligible person from 1 October 2024. The levy is collected through the immigration system, with travellers paying the IVL alongside visa or NZeTA fees. It is charged for most:

- › Visitor visas (excluding partner and dependent categories)
- › New Zealand electronic Travel Authority
- › Student visas (excluding dependent child category)
- › Working Holiday and Work Exchange schemes
- › Student and Trainee Work visas
- › Specific Purpose Work visas.
